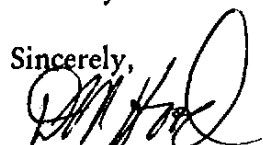
Gentlemen:

I received in the mail on Saturday, 7/19/97, a 2nd Notice for my 1997 Profit Corporation Annual Report. This report, along with check #1734, was mailed back to you on December 28, 1996. Attached is a copy of my check register before & after check #1734 was written, a copy of my January bank statement which shows the check did not clear, and a copy of checks #1733 and #1735 which were written before & after check #1734 (they cleared 1/6/97 and 1/7/97 respectively.) I assure you that I pay all my bills ahead of time, and would be glad to get credit letters confirming this for you if necessary. (Example -Check # 1735 dated 1/2/97 to the Dept of Revenue was not due until 1/20/97). I do reconcile my checking account every month and verify that all checks have cleared, but I just assumed your office might be backed up and had not cashed the check yet. It's not unusual for it to take 6 months for a government check to clear and I figured that you would notify me if you lost the check. On Saturday, this was the first notice I received.
