**NOTICE OF DISSOLUTION

This Notice of Dissolution is submitted by Dick Gore Enterprises, Inc., a Florida corporation (the "*Corporation*"), for resolution of payment of unknown claims against the Corporation as provided in Section 607.1407, Florida Statutes.

3. The harm suffered by claimant.

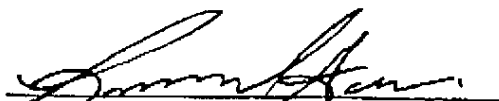
