The undersigned President and Secretary of Tampa Insurance Services, Inc. (the "Corporation"), a Florida Corporation, hereby certify pursuant to §607.1006 of the Florida 1989 Business Corporations Act (the "Act") the following:

**FIRST:** The Articles of Incorporation of Tampa Insurance Services, Inc. have been amended by deleting Article I in its entirety and substituting therefor the following:

**ARTICLE I.**

The name of the corporation is PROGRESSIVE AUTO PRO INSURANCE AGENCY, INC.

**SECOND:** The amendment does not provide for an exchange, reclassification, or cancellation of issued shares.

**THIRD:** The amendment was adopted on September 14, 1998.

**FOURTH:** The amendment was adopted by the sole shareholder of the Corporation pursuant to §607.1003(6) of the Act. The number of votes cast for the amendment by the sole shareholder was sufficient for approval.

**IN WITNESS WHEREOF**, the undersigned Corporation, by its duly elected President and Secretary, has hereunto set its name this 14th day of September, 1998.

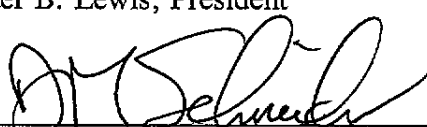
