ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION OF

Pursuant to the provisions of FL SS 607.1006, the undersigned corporation
adopts the following articles of amendment to its articles of incorporation.

1. The name of the corporation is changed to LIDO CLEANERS, INC. from STA-BRITE CLEANERS, INC.
2. The following amendments of the articles of incorporation were adopted by the directors and shareholders of the corporation on July 1, 2002 in the manner prescribed by the Florida Business Corporation Act. The number of votes cast in favor of the amendment was sufficient for approval.
3. The number of shares of the corporation outstanding at the time of adoption was 1,400; and the number of shares entitled to vote on this amendment was 1,400. All authorized, issued and outstanding shares are common and no shareholders are entitled to vote as a class.

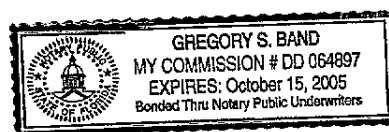
