## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF GTO, INC.



Article IV of the Articles of Incorporation of GTO, Inc. was amended by the corporation's shareholders on May 19, 1999. The corporation is filing these articles of Amendment to Articles of Incorporation pursuant to F.S. 607.0602.

- 1. The name of the corporation is GTO, Inc.
- 2. Article IV of the Articles of Incorporation of GTO, Inc. was amended as follows:

"The maximum number of shares the Corporation shall have authority to issue is two million (2,000,000), par value of \$.001 per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote."

- 3. Implementation of the amendment shall be accomplished as follows: Holders of Preferred Shares shall tender their shares to the corporation, the Preferred Shares shall be canceled of record, and an equal number of Common Shares shall be issued to the holders of former Preferred Shares.
- 4. The foregoing Amendment to Articles of Incorporation was duly adopted by the shareholders on May 19, 1999.
- 5. The number of votes cast for amendment by the shareholders holding Common Shares, and by the shareholders holding Preferred Shares, was sufficient for approval.
