Article II. The dissolution of the corporation was authorized on January 16, 1997.


Article III. The dissolution of the corporation was approved by all of its shareholders.

IN WITNESS WHEREOF, the undersigned President and Secretary of the corporation have executed these Articles of Dissolution, the 22nd day of August, 1997.

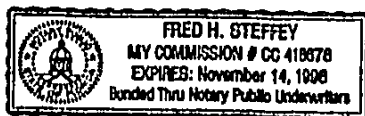
