To Whom It May Concern,

Please be advised, the Rose & Crown Inc, under the administration of Rowan wishes to return the corporation to active status and respectfully submits the following information to accomplish reinstatement, with waiver of penalty.

On 2/1/2001, The Rose & Crown was sold.
The 2001 federal corporate tax return reflects this transaction.

During the month of March 2002, the buyers defaulted and repossession procedures were legally initiated, with actual possession occurring during April. Upon returning the original owners(Rowan) found that all books and records, along with many other items of value, were removed from the premises. Immediate attempts to retrieve these articles, along with the corporation records were unsuccessful and have been fruitless, to this day. The Rowans, at considerable expense, have since discovered and reinstated (made current) all delinquencies, with the considerate help of the representatives, not limited to the following:

- * Internal Revenue Service
- * State Unemployment Tax Account
- * State Sales Tax Account
- * Department Of Business & Professional Regulation
- * Broward County
- * All Utilities, Vendors, Distributors and Associates

Please recognize that the Rowans would not have been aware that the fee (\$ 150.00) for the 2002 Uniform Business Report was not remitted until it was already delinquent. We have no explanation, other then the confusion of repossession, for a lack of response to initial notification of lateness. In fact had we become aware, or been in receipt of same, the matter would have been addressed at that time.

In summary, the Rowans can only bring to your attention, the timely filing of all previous reports in it's history, and request reinstatement without the severity of penalty imposed, considering the particular circumstances regarding this event.

Please recognize that the report would have been filed timely, as in the past, had the opportunity existed to accomplish same.
