ARTICLES OF AMENDMENT

1. 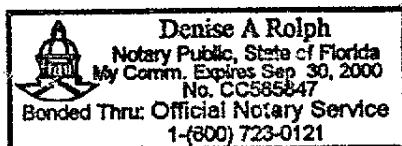
