ARTICLES OF AMENDMENT OF THE ARTICLES OF INCORPORATION OF HIBISCUS PLAZA, INC.

- 1. The name of the corporation is HIBISCUS PLAZA, INC. (the "Corporation").
- 2. The date of filing of the Articles of Incorporation of the Corporation with the Secretary of State of the State of Florida was January 21, 1988, under Document Number K12430.
