The undersigned, pursuant to Section 607.1006, Florida Statutes, does hereby file these Articles of Amendment changing the name of the corporation and says the following:

1. The name of the professional service corporation **Stump, Dietrich, Spears & Norman, P.A.**
2. Article I of the Articles of Incorporation of Frith & Stump, P.A., originally adopted on January 27, 1988 and amended August 1, 1988, January 1, 1991, January 5, 1994, March 1, 1995, July 10, 1995, January 2, 1996, March 10, 2003, January 9, 2004, January 20, 2006 and April 2, 2008, is hereby replaced and further amended as follows:
