



Enclosed is a copy of the Uniform Business Report, which we have downloaded from the internet. I renewed the corporation late September, 2002 after it had been dormant for five years, and had not expect I needed to make any filings until September of 2003. However, I'm now told this form is to be filed each May. I have not received any mailings or instructions from anyone since my lawyer re-activated the company for me.

I have made one correction to the address on item #6 (current registered agent), and am enclosing a check for the \$150 filing fee.
