AMENDMENT TO THE ARTICLES OF INCORPORATION OF

KITCHEN, KABINETS & KOUNTERS, INC.



The undersigned, being all the Shareholders and Directors of KITCHEN, KABINETS & KOUNTERS, INC. (the "Corporation"), do hereby amend the Articles of Incorporation of the Corporation, originally filed March 1, 1988, in the office of the Florida Secretary of State, Document Number K16641, for the following reason and in the following manner:

On November 5, 1999, the Board of Directors of the Corporation unanimously resolved to amend the Corporation's Articles of Incorporation to change the Corporation's name to STEVENS INDUSTRIES INTERNATIONAL, INC., and to change the Corporation's stock structure. These amendments were then voted upon and approved by all of the Shareholders of the Corporation on November 5, 1999, which vote was sufficient for approval.

(1) Article I of the Corporation's Articles of Incorporation is hereby amended to read:

<u>"ARTICLE I - NAME</u>

The name of the Corporation is STEVENS INDUSTRIES INTERNATIONAL, INC."

(2) Article IV of the Corporation's Articles of Incorporation is hereby amended to read:

"ARTICLE IV - STOCK

The aggregate number of shares which the Corporation has authority to issue is Ten Thousand (10,000) shares of voting common stock with a par value of \$1.00 per share and Ten Thousand (10,000) shares of non-voting common stock with a par value of \$1.00 per share."

These Amendments to the Articles of Incorporation will take effect, and the facts stated herein will be true on the date these amendments are filed with the Florida Secretary of State.
