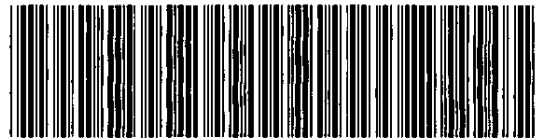

AMENDED AND RESTATED ARTICLES OF INCORPORATION
OF
HIGH VOLTAGE, INC.

ARTICLE I

The name of this Corporation is High Voltage, Inc.

ARTICLE II

The Corporation may engage in any and all lawful businesses for which corporations be incorporated under Chapter 607, Florida Statutes. While pursuing its purposes, the Corporation may exercise the powers granted now or in the future by Chapter 607, Florida Statutes, and by common law.

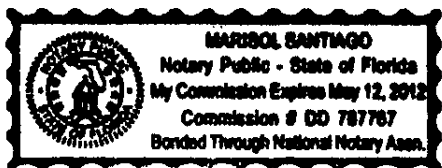


