ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF

MODERN AIR HOME SERVICES, INC.

The undersigned Corporation, in accordance with the Florida Business—Corporation Act and its Bylaws, hereby adopts the following Articles of Amendment:

- 1. The name of the Corporation is MODERN AIR HOME SERVICES, INC.
- 2. Article IV of this Corporation's Articles of Incorporation is hereby amended in its entirety so as to read, after amendment, as follows:

"ARTICLE IV

"CAPITAL STOCK

"This corporation shall be authorized to issue One Thousand (1,000) shares Class A Common Voting Stock and Ninety-Nine Thousand (99,000) shares of Class B Non-Voting Stock both of One Dollar (\$1.00) par value. Said classes of stock shall be identical in all respects except that shareholders owning Class B Non-Voting Common stock shall have no voting rights of any kind or nature whatsoever. The par value and authorized issue of such classes of stock shall be as follows:

Class A Voting Common	\$1.00 per share	1,000 shares
Class B Non-Voting Common	\$1.00 per share	9,000 shares"

3. There are currently issued and outstanding One Thousand (1,000) shares of common stock of the Corporation held by the sole shareholder of the Corporation. Upon the filing of this Amendment the One Thousand (1,000) shares of currently issued common stock shall be exchanged for One Hundred (100) shares of Class A Voting Common Stock and Nine Thousand Nine Hundred (9,900) shares of Class B Non-Voting Common Stock and appropriate stock certificates shall be issued to the current shareholder to evidence the exchange of shares of stock.

This Amendment has been adopted by unanimous Written Action of all of the Shareholders and all of the members of the Board of Directors of the Corporation dated the 27 day of August, 2001, which vote is sufficient to approve the adoption of the Amendment.

IN WITNESS WHEREOF, the undersigned have executed and signed these Articles of Amendment on behalf of the Corporation this 27th day of August, 2001.
