ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF OCCUPATIONAL HEALTH PARTNERS, INC.

Pursuant to the provisions of Sections 607.1001 and 607.1003 of the Florida Business, FLORIDA Corporation Act, Occupational Health Partners, Inc. (the "Corporation") adopts the following Articles of Amendment (this "Amendment") to amend its Articles of Incorporation:

- 1. Name of Corporation. The name of the Corporation is Occupational Health Partners, Inc.
- 2. <u>Text of Amendment</u>. Article III of the Articles of Incorporation is deleted in its entirety and the following is substituted in its stead:

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is ten million (10,000,000) shares of common stock having a \$0.01 par value per share.

- 3. <u>Date of Adoption</u>. The date of adoption of the foregoing Amendment was December 21, 2001.
- 4. <u>Manner of Adoption</u>. The Amendment was adopted by a majority of the directors at a duly called meeting and by a written consent of the holders of a majority of the outstanding shares of the Corporation, whose votes were sufficient to authorize the adoption of this Amendment to the Articles of Incorporation.
