ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF MAGELLAN TRAVEL LTD., INC.



- 1. Pursuant to the provisions of Section 607.1006, Florida Statutes, Magellan Travel Ltd., Inc., a Florida corporation, adopts the following Articles of Amendment to its Articles of Incorporation:
