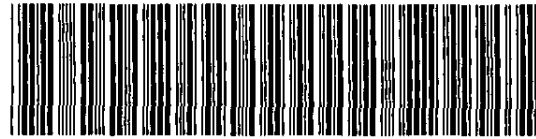

Pursuant to the provision of Section 607.1006, Florida Statutes, the undersigned corporation adopts the following amendment to its Articles of Incorporation:


1. The name of the corporation is CASA SERVICES, INC. (the "Corporation").
