

1. NAME AND JURISDICTION

The merging business entities are La Vue, a corporation organized and existing under the laws of the State of Florida and Emerald Pointe, a corporation organized and existing under the laws of the State of Florida.

2. PLAN OF MERGER

These Articles and Plan of Merger have been approved and executed by both merging entities. These Articles and Plan of Merger were adopted by the Directors and Stockholders of La Vue and Emerald Pointe at Special Joint Meetings to consider and vote upon the merger.

3. **SURVIVING BUSINESS ENTITY**

The name of the surviving business entity shall be **Emerald Pointe** of Hollywood, Inc.

4. **EFFECTIVE DATE**

The merger shall be effective upon the date of the filing of these Articles of Merger with the Florida Secretary of State (the "Effective Date").

5. ARTICLES OF INCORPORATION

6. BY-LAWS

8. OFFICERS




