AMENDED AND RESTATED ARTICLES OF INCORPORATION
OF
PARADISE COLOR INCORPORATED

Pursuant to Section 607.1006 and 607.1007 of the Florida Business Corporation Act, the undersigned, being the Chief Financial Officer of PARADISE COLOR INCORPORATED, a Florida corporation (the "Corporation"), hereby executes and submits for filing with the Department of State, State of Florida, these Amended and Restated Articles of Incorporation to read as follows:

ARTICLE I

NAME

The name of the corporation is PARADISE COLOR INCORPORATED.

ARTICLE II

PURPOSE

The corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE III

CAPITAL STOCK

The aggregate number of shares which the Corporation shall have authority to issue is Ten Thousand (10,000) shares of common stock, all of which are to have a par value of One Dollar (\$1.00) per share. Notwithstanding anything to the contrary in these Amended and Restated Articles of Incorporation, the Corporation shall not issue any non-voting equity securities within the meaning of 11 U.S.C. § 1123(a)(6).

ARTICLE IV

REGISTERED OFFICE AND AGENT

The street address of the registered office of the Corporation and the name of the registered agent of the Corporation at such office is:

ARTICLE V

BOARD OF DIRECTORS

The Board of Directors of the Corporation shall be comprised of the individuals elected pursuant to the Bylaws of the Corporation. The number of directors may be increased or decreased from time to time as provided for in the Bylaws of the Corporation.

ARTICLE VI

BYLAWS

The Board of Directors is expressly authorized to adopt, amend or repeal the Bylaws of the Corporation.

ARTICLE VII

INDEMNIFICATION

The Corporation shall indemnify any officer or director or any former officer or director of the Corporation, to the fullest extent permitted by law.

ARTICLE VIII

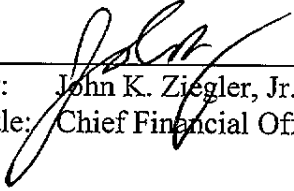
AMENDMENT
