



**ARTICLES OF MERGER OF**  
**FIRST CITY RESOURCES COMPANY, a Florida corporation**  
**AND**  
**COBRA COAL COMPANY, a West Virginia corporation**

First City Resources Company and Cobra Coal Company set forth the following

**Articles of Merger.**

- (a) The plan of merger is:

(1) The names of the corporations proposing to merge are First City Resources Company, a Florida corporation, and Cobra Coal Company, a West Virginia corporation, and the surviving corporation shall be Cobra Coal Company.

(2) Upon such merger becoming effective, all of the assets presently owned by First City Resources Company will become the property of Cobra Coal Company and Cobra Coal Company will assume all of the liabilities of First City Resources Company. The officers and directors of Cobra Coal Company shall be the officers and directors of the surviving corporation until their successors shall be elected and qualified. The By-Laws of Cobra Coal Company shall remain the same as they now are for the surviving corporation and the registered agent of Cobra Coal Company and the registered office of Cobra Coal Company shall remain the registered agent and registered office of the surviving corporation.

(3) The shares of First City Resources Company shall be convertible to shares of stock of Cobra Coal Company at the ratio of one (1) share of stock of Cobra Coal Company to one (1) share of stock of First City Resources Company.

(b) The above plan of merger was approved at a meeting of the Board of Directors of each of the corporations herein named held on June 1, 1997, each stockholder of each corporation waived notice as required by applicable law and the plan set forth above was adopted by unanimous written consent of the stockholders of each of the corporations at meetings of such stockholders held on June 1, 1997.

(c) Cobra Coal Company has one thousand (1,000) shares of stock outstanding and all are of the same class. First City Resources Company has one thousand (1,000) shares of stock outstanding and all are of the same class.

(d) As to Cobra Coal Company, the number of shares voted for the plan of merger was one thousand (1,000) and the number of shares voted against the plan of merger was zero (0). As to First City Resources Company, the number of shares voted for the plan of merger was one thousand (1,000) and the number of shares voted against the plan of merger was zero (0).

(e) The stated capital of the surviving corporation on the effective date of the merger will be Fifty Thousand Dollars (\$50,000.00).


