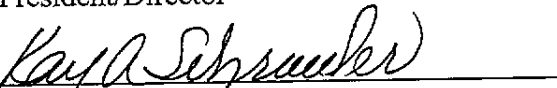
7. This dissolution shall be effective December 30, 1999, and was authorized by the shareholders on December 29, 1999.
