REQUEST TO REINSTATE

Plantation Construction Inc. is in receipt of your letter of December 28, 2001, along with our firm's application for re-instatement. Plantation Construction finds exception to the contents of the December 28th letter.

Plantation Construction Inc. found out in December 2001, that the State of Florida had administratively dissolved the firm due to Plantation's failure to file it's 1999 corporate annual report. Upon telephone contact with the Division of Corporations, Plantation Construction was informed of the procedures to re-instate by the state and was furnished the proper forms to submit by the state.
