Thank you for the information you provided me on November 30, 1999 regarding the reinstatement and possible merger of James & Ludy, Inc., which was administratively dissolved on August 23, 1996. Per your suggestion, I am enclosing the documents necessary to reinstate James & Ludy, Inc. immediately pursuant to Florida Statutes § 607-1422.

My attorney John McMillen spoke with you on November 30, 1999 about the procedure for reinstating this corporation in Florida. To give you some background, this corporation was awarded to me after lengthy litigation as part of my divorce from my ex-husband, James Strother. He and his associate, George T. Eldridge, sought to prevent me from gaining control of the corporation and its assets, all of which are in North Carolina.

Unfortunately, the corporation was administratively dissolved on August 23, 1996 before I could assert control over the corporation. We are now trying to have James & Ludy, Inc. reinstated to carry out other corporate functions and my attorney is forwarding with this letter the necessary Annual Reports and overdue fees. I understand the reinstatement fee is \$600.00 and I would appreciate it if you would consider waiving this fee in light of the circumstances.
