1. ARTICLE I of the Articles of Incorporation of PRONTO FOOD MARKET, INC. is amended to read as follows:

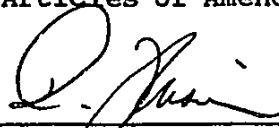
ARTICLE I

2. The foregoing amendment was adopted by the shareholders of this corporation on March 11, 1997.

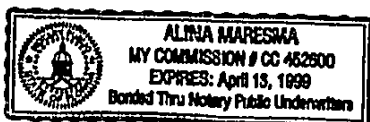
3. The amendment was approved by unanimous consent of all shareholders entitled to vote.

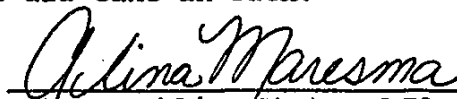
