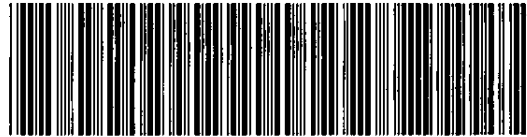

FIRST: Article I is hereby amended and restated in its entirety to read as follows:

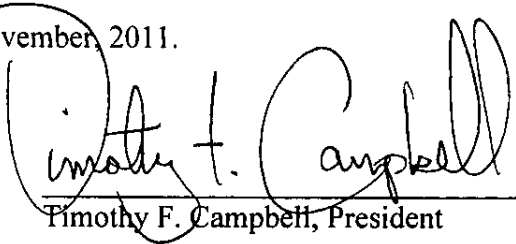
"ARTICLE I. NAME
