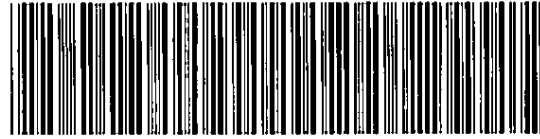

ARTICLE 1

NAME

The name of this Corporation is BOB DEVOS POOLS, INC.

ARTICLE 2

DURATION

The period of duration of this Corporation is perpetual.
