Dear Ms. Hood,

Please see attached correspondence as proof I've been diligently trying to update my corporation with your office. Last Spring, I sent my check of \$150 along with my completed UBR. However, it was lost in the mail and I didn't know it was lost until I received a 60 day warning that Suncoast Sentinel, Inc. would be dissolved if I didn't register before the deadline.

On August 29, 03, I immediately went online and filed the UBR information again; however, the online payment system would only accept \$550.00 payment. I had learned that since you never received my first check, that I could request the \$400 penalty be waived. Therefore, under separate cover and sent through the U.S. Postal Service, I wrote a letter explaining my problem and attached a check for \$150.00 requesting that the penalty be waived. I also sent copies of my online transaction along with my letter.

In a letter dated September 3, I received from your office my letter and my check; returned because the UBR wasn't attached. Although your letter was dated 9/3/03, it did not reach my desk until September 19, at which time I was under a doctor's care and admitted to North Okaloosa Medical Center for back surgery. Upon returning to work, I contacted your office and spoke with "Justin" on September 29, 03, who said he would send another UBR form for me to file. He asked whether a UBR report was attached to your correspondence dated September 3 and I informed him no form came with your letter. To date, I have not received that form. Then, yesterday (Oct. 9, 03) I received notice that in fact my corporation had been dissolved!

Today, I called again and spoke with Tyrone Scott in your office who advised me to fill out the form that accompanied the notice of dissolution and again, write a letter explaining what has happened this year to date and request that the corporation be reinstated and the penalty fee waived. He also told me to include a payment of \$8.75 so I may receive from you confirmation that my corporation has in fact been reinstated so I'm not left in the dark as I was earlier this year, not knowing anything was wrong.

I hope this clears up this matter as, to the best of my knowledge, I have followed the law to the best of my ability. Thank you for your consideration in the matter.
