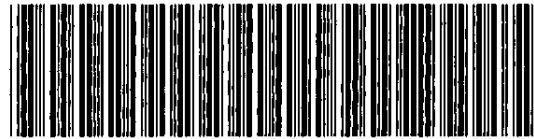

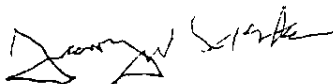

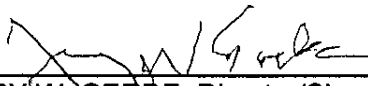
ARTICLE I
