This Certificate of Conversion is submitted to convert Syngenta Flowers Inc., a Florida for profit corporation (the "Domestic Corporation"), into a Delaware limited liability company (the "Delaware LLC"), in accordance with Section 607.1113 of the Florida Business Corporation Act ("FBCA"):

- 1. <u>Conversion</u>. The Domestic Corporation has been converted to a Delaware limited liability company (the "Conversion") in compliance with Chapter 607 of the FBCA and the Conversion complies with the applicable laws of Delaware governing the Delaware LLC, including Section 18-214 of the Delaware Limited Liability Company Act, 6 Del. C. §§ 18-101 et seq.
- 2. <u>Approval of Conversion</u>. The Plan of Conversion for converting the Domestic Corporation to the Delaware LLC was approved by the Domestic Corporation in accordance with Chapter 607 of the FBCA. If applicable, the written consent of each shareholder who, as a result of the conversion, is now a general partner of the surviving entity was obtained pursuant to Section 607.1112(6) of the FBCA.
- 3. <u>Effective Date</u>. The effective date of the Conversion under the laws of Delaware is December 31, 2016. The Conversion shall be effective in Florida on December 31, 2016.
