Dear Ms. Connell:

This Law Firm represents Dr. Johnny Jada and Jada Bros., Inc. ("JBI"). The letter acts as the requisite Statement of Facts regarding the company as provided to me by my client.

Jada Bros., Inc. was incorporated in 1988. The history of the company's annual reports back to the inception are readily available on Sunbiz. Prior to 1994, Hani Naim Jada held the corporate offices. In 1994, Johnny N. Jada purchased Hani Naim Jada's ownership interest in the company. As evidenced by the 1994 Annual Report, Hani Naim Jada, himself, filed the Annual Report removing himself and adding Johnny N. Jada as the President, Secretary, Treasurer and Director, a copy of which is attached hereto as Exhibit "A." Since that time, Johnny N. Jada has been the sole owner and Director, as well as all of the officers of the company. The Annual Reports on file since 1994 with the Florida Department of State show that Johnny N. Jada has held the offices of President, Secretary, Treasurer and Director, solely. A letter from Johnny N. Jada's CPA verifying that Johnny N. Jada has been the sole owner in the company since 1994 is attached hereto as Exhibit "B."

On September 28, 2018, Mr. Hani Naim Aljada (a/k/a Hani Naim Jada), filed Articles of Amendment with the Secretary of State, Division of Corporations to amend Florida Document Number K33618 to remove Johnny N. Jada and add himself as the designated Officers and Directors of the company. In his Amendment, Mr. Hani Naim Aljada affirmed "that the amendment(s) was/were adopted by the Shareholders." According to my client, Mr. Aljada has not been involved in Jada Bros., Inc. in any way, whatsoever, since 1994. Therefore, it is my client's position that he has violated Florida Statute 817.155, Fraudulent Practices, by knowingly filing false information with the State of Florida as the filing was done without authority or approval of the sole shareholder, sole member of the board of directors and the sole officer, Johnny N. Jada.

On October 12, 2018 Johnny N. Jada was made aware of Hani Naim Aljada's fraudulent filing and filed online his own lawful Amended Annual Report removing Hani Naim Aljada from the company and restoring himself as the rightful Officers. At the same time, a cease and desist letter was served on Hani Naim Aljada regarding the fraudulent activities. A copy of the that letter is attached hereto as Exhibit "C."

On October 15, 2018 Hani Naim Aljada once again filed a fraudulent Amended Annual Report removing Johnny N. Jada and replacing him with Hani Naim Aljada. An Amended Annual Return is being filed concurrently herewith to correct the record again identifying Johnny N. Jada as P, V, S, T, D of the corporation.

THIS LETTER SERVES AS A REQUEST THAT NO FURTHER AMENDMENTS BE ACCEPTED FROM HANI NAIM ALJADA UNTIL SUCH TIME AS A COURT ORDER IS ISSUED DETERMINING THE OWNERSHIP OF THE CORPORATION.

Dear Mr. Aljada:

This Law Firm represents Dr. Johnny Jada and Jada Bros., Inc. ("JBI"). Any future communications regarding this matter should be directed to my attention.

It is my understanding that on September 28, 2018, you filed an amended Uniform Business Report with the Secretary of State of Florida, Division of Corporations to amend Florida Document Number K33618 to add your name as the president, vice president, secretary, treasurer and board of director. Your illegal filing was done without authority or approval of the sole shareholder, sole member of the board of directors and the sole officer, Dr. Johnny Jada.

You may recall that your full and complete interest in JBI was purchased back in 1994/95. Dr. Johnny Jada made full and complete payment for your shares. Moreover, Dr. Johnny Jada has owned and operated the business since 1995 without anyone else's involvement, interest or ownership. Your actions constitute fraud and will be appropriately reported to the State of Florida. A copy of your filing, where you mentioned it was approved and adopted by the shareholders is enclosed. Mr. Aljada, according to the federal tax returns that were filed for the past twenty-five years or so, the sole shareholder of JBI was Dr. Johnny Jada. You have not been involved in JBI in any way, whatsoever, since 1995. My client's position is clear; you violated Florida Statute 817.155, Fraudulent Practices, by knowingly filing false information with the State of Florida. A copy of the statute is enclosed with this letter.

Further, it is our understanding that you have also fraudulently changed the ownership information regarding the Retail Beverage License with the State of Florida Division of Alcohol and Tobacco.

Mr. Al Jada, according to the records filed with the Internal Revenue Service for the past twenty-five years and the company records as filed with the Secretary of State for the same time period, you were not and are not an owner, officer or director of JBI. It is clear that Dr. Johnny Jada is the sole owner, officer and director. Moreover, according to your Family Law Financial Affidavit filed in your recent divorce from Karin Aljada, you made no reference, whatsoever, to JBI in connection with your income. You have not been listed on JBI's tax return as a shareholder and therefore, are not a shareholder.

You are hereby demanded to cease and desist your actions to remove Dr. Johnny Jada from the Secretary of State, Division of Corporations website, the State of Florida Division of Alcohol and Tobacco, and your actions to interfere, in any way, with the corporation, its assets, officers or employees. In the event you fail to cease and desist, Jada Bros., Inc. will expeditiously exercise any and all legal remedies available to it.

PLEASE GOVERN YOURSELF ACCORDINGLY.
