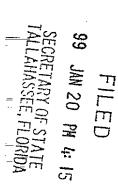

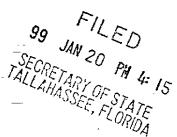

## ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF - FORTUNE HOTELS, INC.



Pursuant to the requirements of Sections 607.1003 and 607.1006, Florida Statutes, the undersigned does hereby make, swear to, adopt and file these Articles of Amendment to the Articles of Incorporation of FORTUNE HOTELS, INC. (the "Corporation"), which Corporation was incorporated under the laws of the State of Florida effective on September 20, 1988, under Charter No. K33619.

1. The members of the Board of Directors of the Corporation have recommended the following proposed change to the Articles of Incorporation to the shareholders of the Corporation, and the shareholders of the Corporation have unanimously voted to change the Corporation's Articles of Incorporation.

Therefore, Article IV of the Corporation's Articles of Incorporation shall be deleted in its entirety and the following inserted in its place:

## "ARTICLE IV

## CAPITAL STOCK

The total number of shares of capital stock which the Corporation has the authority to issue is 101,000,000 shares, which shall consist of 100,000,000 shares of voting Common Stock, \$.0001 par value per share ("Voting Common Stock") and 1,000,000 shares of non-voting Common Stock, \$.0001 par value per share ("Non-Voting Common Stock"). Holders of Non-Voting Common Stock shall have no voting rights; otherwise, the Non-Voting Common Stock shall be identical in all respects to the Voting Common Stock including, without limitation, as to the payment of dividends and distribution of proceeds in connection with the liquidation of the Corporation."

- 2. All other provisions of the Corporation's Articles of Incorporation shall remain in full force and effect, unaltered except as expressly provided above.
- 3. The foregoing amendment to the Articles of Incorporation was unanimously adopted by all the members of the Board of Directors and all the shareholders of the Corporation on the 12 day of January, 1999, and the number of votes cast for this amendment was sufficient for approval.
