


Article III. of the articles of incorporation of L.L. SWOR, INC. was amended by the corporation's shareholders on February 4, 2000. The corporation is filing these articles of amendment to articles of incorporation pursuant to F.S. 607.0602.

1. The name of the corporation is L.L. SWOR, INC.
2. Article III. of the articles of incorporation of L.L. SWOR, INC. was amended as follows:

"The aggregate number of shares of capital stock which the Corporation shall have authority to issue shall be 10,000 shares of no par value stock which stock shall qualify under Section 1244, Internal Revenue Code."

3. The foregoing amendment to articles of incorporation was duly adopted by the shareholders on February 4, 2000.
