To Whom It May Concern:

I have enclosed the normal annual renewal fee of \$150.00 and hope that you will accept the normal renewal fee of \$150.00 attached for each Corporation instead of the late filing fee of \$550.00 which would normally include a late filing fee of \$400.00 if paid after May 1, 2001.

I was shocked when I got the notice of penalty and no filing. I respectfully request an abatement of the late filing fee for the following reasons:

I am an accountant and own two small S-Corporations. I had instructed my part-time secretary to pay the bills and had thought the Annual Reports had been paid. **However, I had not received the original Uniform Business Report and did not realize it was not filed until I received your notice.** Additionally I always instruct my clients to pay timely. Since the bill comes due in May I had not the time to overlook my own corporate bills not paid and had assumed my part-time secretary paid the annual report. My brother has been in bad health and I was pre-occupied with the tax business and his care and did not realize the bill was not paid until I received the notice. I have always paid the annual report and never been late in 26 years. This is a small business and creates a great hardship when over \$800.00 is charged as a late fee. Under the circumstances I would appreciate an abatement of the late fee and an acceptance of the annual report.
