**FIRST:** The name of the corporation is August, Comiter & Kulunas, PA ("the Corporation").

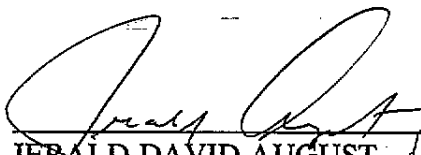
**SECOND:** Article I of the Articles of Incorporation of the corporation is amended to read as follows:

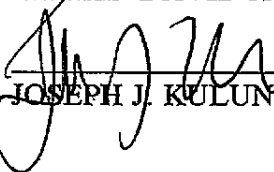
Article I. Name
