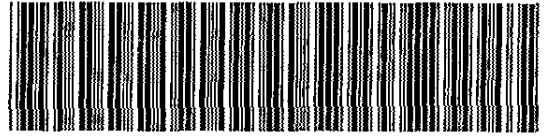



**FIRST:** The name of the corporation is August & Kulunas, P.A. (the "Corporation").


**SECOND:** Article I of the Articles of Incorporation of the corporation is amended to read as follows:
