I have received your form letter 796A00046548 for each of the above noted firms in which you request the following: a \$175 reinstatement (penalty) fee, a \$61.25 filing fee and a \$138.75 supplemental fee. This letter will serve to protest each firm's fees separately and collectively.

I have filed the appropriate forms in a timely manner since I began doing business in Florida in 1982. Typically, I received the application(s) in January and a follow-up reminder in May.


I state, without equivocation, that none of the firms received the first or second notice - nor did we receive a notice of proposed dissolution, which would seem appropriate. All we received were notifications that the firms had been dissolved.

Conversations with your office, elicited a "the state isn't required to send out the notices." Did you? If not, it would appear that the state shares the burden for our failure to comply.

If the State of Florida wants to omit the notification for economy reasons, or whatever, the least it can do is forewarn us. Anything less is simply not fair play.

Consequently, we protest your proposed fee of \$375.00 per company and request reconsideration or a hearing on the matter.
