We are filing the enclosed UBRs for the above two related taxpayers. The UBRs have been signed by an officer of the corporations, and a check is enclosed for \$150.00 for each UBR.

The UBR is being filed late, however we haven't enclosed the late fee of \$400, due to unusual circumstances. The late filing was due to our office, not any action of the taxpayer. We are writing to ask that you waive the late penalty.

The taxpayer brought the 2001 accounting work to our office in April, 2002, for us to do the 2001 corporate income tax return. Like many clients, the taxpayers were unsure as to what to do with the 2002 UBR, and put it with their accounting work, thinking we needed to prepare something on it for them. Under normal circumstances, we just send it back to the client and tell them to sign and mail it. However, in this case, we had extended their corporate tax returns, and were not able to begin their work until June, 2002. We found the UBR's when we opened the files to begin the work.

We feel ~~we~~ responsible as the client sent the form to us for a determination as to what to do with it. This is a very unusual situation, and under the circumstances, we request the \$400 late fee be waived.
