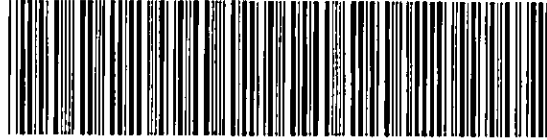

Articles of Amendment

Pursuant to the provisions of Section 607.1006 of the Florida Statutes International Digital Holding, Inc., a Florida corporation, does hereby amend its Articles of Incorporation.

1. The name of the corporation whose Articles of Incorporation are being amended by these Articles of Amendment is International Digital Holding, Inc., a Florida corporation.
2. After the filing and effectiveness pursuant to the Florida Business Corporations Act of these Articles of Amendment to the Articles of Incorporation of the Corporation, (the "Effective Time"), Article III shall be amended as follows:

"The maximum number of shares of capital stock that the Corporation is authorized to issue and have outstanding is Eight Hundred and Fifty Million (850,000,000) shares, of which Eight Hundred Million (800,000,000) shares shall be \$.001 par value Common Stock and Fifty Million (50,000,000) shares shall be \$.01 par value Preferred Stock."

3. The amendment to the Articles of Incorporation of International Digital Holding, Inc., a Florida corporation, set forth in paragraph 2 above was duly adopted by the Board of Directors of the corporation as of April 20, 2022. The amendment was duly adopted by the shareholders. The number of votes cast for the amendment by the shareholders was sufficient for approval.
