to
ARTICLES OF INCORPORATION

Pursuant to the provisions of Section 607.1006, Florida Statutes, the undersigned Florida corporation adopts the following Articles of Amendment to its Articles of Incorporation.

FIRST: The name of the corporation is:

Applied Mapping, Inc.

SECOND: The Article III of the Articles of Incorporation is amended in its entirety to read as follows:

"ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock this corporation is authorized to have outstanding at any one time is ten thousand (10,000) shares of common stock having One Dollar (\$1.00) par value per share."

THIRD: The date of the adoption of the amendment was November 1, 1998.

FOURTH: The amendment was approved by the shareholders of the corporation. The number of votes cast for the amendment was sufficient for approval.
