ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION
OF
MOUNTAIN DISTRIBUTORS, INC.

The Articles of Incorporation of MOUNTAIN DISTRIBUTORS, INC. heretofore approved and filed in the office of the Secretary of State of Florida on October 28, 1988, Document No. K41939, pursuant to Section 607.1006 of the Florida Business Corporation Act, is hereby amended in the following particulars:

1. Article III of the Articles of Incorporation is deleted in its entirety and the following Article II is substituted therefor:

"ARTICLE III
PURPOSE

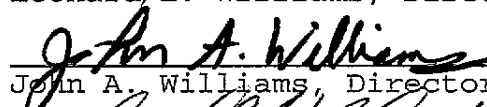
"This corporation is organized to hold title to property, collect income from that property, and turn over the entire amount, less expenses, to a single parent organization that is exempt under Section 501(a) of the Code."

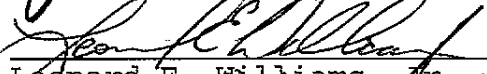

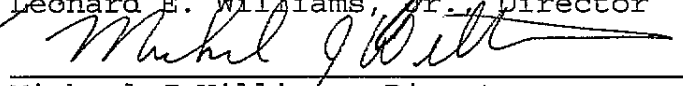
In all other respects, the Articles of Incorporation shall remain as they were prior to this Amendment being adopted.

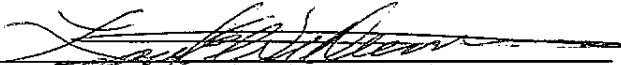
