ARTICLES OF MERGER OF RI/MD MERGER CORP., a Florida corporation INTO MAROONE DODGE, INC., a Florida corporation

Pursuant to the provisions of Section 607.1101 and Section 607.1105 of the Florida Business Corporation Act, RI/MD MERGER CORP., a Florida corporation (the "Merger Sub"), and MAROONE DODGE, INC., a Florida corporation (the "Surviving Corporation"), hereby adopt the following Articles of Merger for the purpose of merging the Merger Sub with and into the Surviving Corporation (the "Merger"). All of the outstanding shares of common stock of Merger Sub are held by Republic Industries, Inc., a Delaware corporation ("Republic").

FIRST: The plan of merger for the Merger (the "Plan of Merger"), pursuant to Section 607.1101 of the Florida Business Corporation Act (the "FBCA"), is as set forth in these Articles of Merger, including Exhibits A, B and C hereto, which are incorporated herein and constitute part of these Articles of Merger.

SECOND: The Merger shall be effective upon the filing of these Articles of Merger with the Secretary of State of the State of Florida (the "Effective Time"). At the Effective Time, by virtue of the Merger and without any action on the part of the Merger Sub, the Surviving Corporation or Republic, (i) the Merger Sub shall be merged with and into the Surviving Corporation, with the Surviving Corporation being the surviving corporation of the Merger and the separate existence of Merger Sub shall thereupon cease, (ii) all of the shares of capital stock of the Surviving Corporation outstanding at the Effective Time shall be converted into the right to receive, in the aggregate, such number of shares of common stock, par value \$.01 per share, of Republic as set forth in Exhibit A hereto (the "Republic Shares"), and such Republic Shares shall be allocated among the shareholders of the Surviving Corporation as provided in Exhibit A hereto, and (iii) each share of common stock of Merger Sub outstanding at the Effective Time shall be converted into one share of the voting common stock of the Surviving Corporation,

resulting in the Surviving Corporation becoming a wholly-owned subsidiary of Republic. The Merger shall have the effects set forth in Section 607.1106 of the FBCA, and all property, rights, privileges, policies and franchises of each of the Surviving Corporation and the Merger Sub shall vest in the Surviving Corporation and all debts, liabilities and duties of each of the Surviving Corporations and the Merger Sub shall become the debts, liabilities and duties of the Surviving Corporation.

THIRD: The Articles of Incorporation of the Surviving Corporation shall, as of the Effective Time, be amended and restated in their entirety as set forth in Exhibit B and shall continue in full force and effect until changed, altered or amended as therein provided and in the manner prescribed by the laws of the State of Florida.

FOURTH: The Bylaws of Merger Sub as in effect at the Effective Time shall be the Bylaws of the Surviving Corporation thereafter, unless and until amended in accordance with applicable law.

FIFTH: The persons listed on Exhibit C hereto shall become the officers and directors of the Surviving Corporation at the Effective Time, each to hold thereafter a directorship and/or office of the Surviving Corporation as indicated in Exhibit C, until their respective successors are duly elected and qualified.

SIXTH: The Plan of Merger was approved by unanimous written consent of the Board of Directors and shareholders of the Surviving Corporation dated as of January 12, 1997, and by unanimous written consent of the Board of Directors and sole shareholder of the Merger Sub dated as of January 12, 1997.
