Pursuant to the provisions of Section 607.1006, Florida Statutes, ESKIMO ICE CORP., a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation which were filed with the Florida Department of State on November 8, 1988, Charter Number K44088.

FIRST: Article I of the Articles of Incorporation of this Corporation is amended to read in its entirety as follows:

Article I. Corporation Name

The name of the corporation shall be WOG ENTERPRISES, INC.

SECOND: The foregoing amendment was adopted by the sole director and sole shareholder of the Corporation, at a special shareholders meeting held March 24, 2006. The number of votes cast by the sole shareholder voting for the amendment was sufficient for approval.
