ARTICLES OF DISSOLUTION OF
DR. JORGE A. AGUILAR, M.D., P.A. SECRETARY OF STATE
TALLAHASSEE, FLORIDA

The undersigned President of DR. JORGE A. AGUILAR, M.D., P.A., a Florida corporation, pursuant to the provisions of Florida Statutes § 607.1402, adopts the following Articles of Dissolution on behalf of the corporation:

ARTICLE I
