## ARTICLES OF AMENDMENT OF ARTICLES OF INCORPORATION

OF

## NATURAL HEALTH TRENDS CORP.

A Signatural Mark Trends Corp.

Pursuant to the provisions of section 607.1006, Florida Statutes, Natural Health Trends Corp. (the "Corporation"), hereby adopts the following articles of amendment of articles of incorporation:

- 1. To change article FOURTH: to effect a one for 40 reverse stock split, to change as a result of the one for 40 reverse stock split 200,000,000 authorized shares of common stock, par value \$.001 per share (the "Common Stock") (pre-split), 38,380,427 of which are issued into 5,000,000 authorized shares of Common Stock (post-split), and 959,952 issued shares, par value \$.001 per share, said change to be at the rate of one-fortieth of an issued share, for each share of Common Stock, provided however, that in the event that such result includes a fraction of a share, then each fraction of a share shall be rounded up to the nearest whole share; to reduce the stated capital of the Corporation by the amount of \$.001 in respect of each of the issued shares of Common Stock so that the aggregate stated capital of the Corporation is reduced from 38,380.43 to 959.52 plus \$.001 multiplied by the number of additional shares of Common Stock issued as a result of rounding the fractional shares.
- 2. ARTICLE IV is hereby amended by amending the first paragraph of Article IV to read as follows:

The aggregate number of shares of all classes of stock which the Corporation is authorized to issue is 6,500,000 shares, consisting of 5,000,000 shares of common stock, \$.001 par value per share (the "Common Stock"), and 1,500,000 shares of preferred stock, \$.001 par value per share (the "Preferred Stock").

These Articles of Amendment to the Articles of Incorporation were adopted by the Board of Directors without shareholder action and shareholder action was not required.

The effective date and effective time of these Articles of Amendment of Articles of Incorporation shall be 7:00 a.m. on April 6, 1998.
