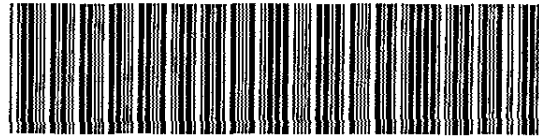

Pursuant to the provisions of Section 607.1006, Florida Statutes, this corporation adopts the following Articles of Amendment to its Articles of Incorporation:


1. The current name of the corporation is LUCIO, BRONSTEIN, GARBETT, STIPHANY & ALLEN, P.A.
