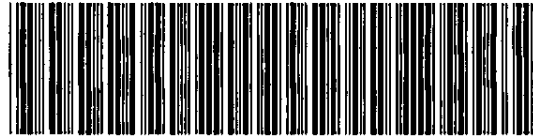



3. The effective date for the dissolution of the Corporation is the date of filing with the Florida Secretary of State, Corporations Division.

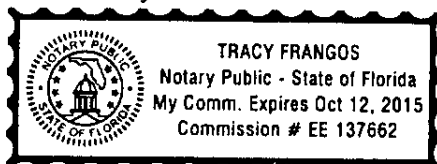
