This letter respectfully requests a waiver of the additional filing fee due for the following corporations:

1. Marc J. Chamberland, P.A. (we did not receive the 1st notice; we received the 2nd notice only by mail after May 1, 2000).
2. John Daly Enterprises, Inc. (we did not receive the 1st notice; we received the 2nd notice only by mail after May 1, 2000).

I believe that in each of the above instances, the non-receipt of the 1st notice was due simply to misdeliveries by the postal service. This is not the only important mail which we were to receive at our new address that was either delivered to a different tenant or suite # or simply disappeared. This was due in part to a corporate office move which occurred around this time period.
