**ARTICLE II - DATE DISSOLUTION AUTHORIZED**

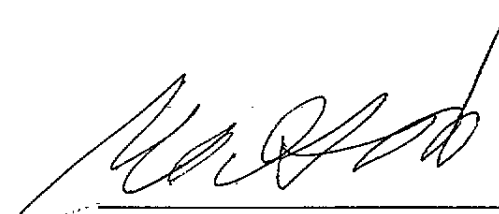
The dissolution of this Corporation was authorized on the 1<sup>ST</sup> day of JANUARY, 1999. As
