The following is an explanation in to the chain of events that have occurred leading to the confusion of having the Corporate status of Majestic Group Enterprises, Inc. renewed. Attached is the second notice of filing for the above Corp. this was what led me to contact your office today 7/1/98, thus inquiring in the nature and reason for the second notice. In the review of the files the receiver of my phone call mentioned that payment was received in May, 1998 and was returned to me at my new home address of 2555 NW 40th Street, Boca Raton, Fl.33434, but as of today I have not received your notice of return application, along with the check issued to renew the Corp. Filing. I have had a very bad end of year "97" starting out with an auto accident in the later part of Nov. 1997, this accident has resulted in 3 herniated disks, of which I was trying to correct with 3 days a week therapy and experiencing a very frighting method of detecting the damage through a "MRI", that required my ingesting of tranquilizers of 10 mg in order for me to enter the equipment. Therapy continued to after the holidays and I was not able to function to and comfortable level as before.

On Jan. 13,1998 standing at a stop light, I was rear end for a second time. At this stage therapy was still continuing. In the month of March I moved to the new location and as luck be met up with a terrible accident with moving of a large cabinet, I ruptured my biceps and fore arm muscle, tearing the biceps clear from the tendon, thus requiring immediate surgery, which was a 3hr. surgery. The hospital had me on all sorts of demorall injections and days after my release, percosets were continued for the remained of April, at the rate of 2 every 4 hrs. Needless to tell you that I was not at all myself. Throughout the ordeal from the first accident to the recovery of surgery. It was at the end of April, that finally I was able the attempt to get to my business, I'm only a one man operation with this business, and some how in my haste to send out all the delayed bills, the fact of studying the package with all of the new rules and requirements.

The fact of the matter is that having renewed the Corp. Filing for the last 10yrs around the May time frame further prevented the reading of the forms more thoroughly, since all of the previous yrs of straight forward filing and being hurry to get all of the billing completed with. Additionally, in the coarse of moving all of my mail was misplaced through the help of neighbors trying to complete my move after the accident, while moving.

Please try to understand my situation and hopefully you can help me for this situation. I have never had such a dilemma occur and monetarily be at such odds, please try to waive the exorbitant penalty, I have enclosed a check for \$150.00
