ARTICLES OF AMENDMENT OF TORWEST, INC.



The undersigned, being the President of TORWEST, INC., a Florida Corporation (the "Corporation"), hereby certifies, pursuant to §607.1006 of the Florida Business Corporation Act, as follows:

- 1. The name of the Corporation is TORWEST, INC.
- 2. Article IV of the Articles of Incorporation is deleted in its entirety and replaced by the following:

ARTICLE IV CAPITAL STOCK

The Corporation is authorized to issue Six Hundred and Ninety Thousand (690,000) shares of capital stock, \$.01 par value, of which One Hundred Thousand (100,000) shares are designated Common Stock and Five Hundred and Ninety Hundred Thousand (590,000) are designated Preferred Stock. All shares of Common Stock shall be identical with each other in every respect and the holders thereof shall be entitled to one vote for each share upon all matters upon which shareholders have the right to vote. All shares of Preferred Stock shall be entitled to one vote for each share upon all matters upon which shareholders have the right to vote.

Fifty Thousand (50,000) shares of the Preferred Stock authorized in this Article IV are designated as "Series F Preferred Stock". Thirty Thousand (30,000) shares of the Preferred Stock authorized in this Article IV are designated as "Series G Preferred Stock". Thirty Thousand (30,000) shares of the Preferred Stock authorized in this Article IV are designated as "Series H Preferred Stock". Thirty Thousand (30,000) shares of the Preferred Stock authorized in this Article IV are designated as "Series I Preferred Stock". Series A Preferred Stock, Series B Preferred Stock, Series C Preferred Stock, Series D Preferred Stock, Series E Preferred Stock, Series F Preferred Stock, Series G Preferred Stock, Series H Preferred Stock, Series I Preferred Stock, Series J Preferred Stock, Series K Preferred Stock, Series L Preferred Stock, Series M Preferred Stock, Series N Preferred Stock, Series O Preferred Stock and Series P Preferred Stock shall have the preferences, limitations and relative rights as set forth below:
